Microsoft Releases Windows 10

Microsoft released Windows 10 on July 29, 2015. This is a free upgrade for Windows 7 and Windows 8.1 users. Many of our customers have taken advantage of this free update. We are happy to report that SACS Housing Software works great with this version of Windows.

A new report has been added to allow agencies to easily identify families that are over income limits.

Advanced Search

The applicant and tenant search screens now have an advanced search option. This option allows users to easily filter the search results.

Tenant Leases

You can now have different leases for each authority number.

Application Listing

The report's name has been changed to Waiting List.

Accounts Payable Payments

The new Payments Receiving program can be used to receive checks from vendors.

Developer's Corner

Our developers spent a lot of time during the last quarter of 2015 working on changes for the new ACA reporting requirements. Our technical support staff also answered a large number of calls. We appreciate your patience as we all figure out this new requirement. Now that we have the first year out of the way, reporting for the 2016 tax year should be easier.

As announced on the cover page, SACS Software now supports taking debit and credit cards. This capability is integrated into Payments and Charges. When you take a payment, the payment terminal will automatically show the amount that will be charged. Contact SACS Sales for more information on this new feature.

The next software release removes the requirement to have Microsoft Word installed on every end-user computer. Microsoft Word was required to print all of our letters and leases.

An option has been added that will

allow you to view all letters and leases as PDF documents. You will still need Microsoft Word if you want to modify the source Word documents.

We are working on changes in the Inspection system to make it more responsive. Look for changes that will allow you to have different letters based on the inspection type.

We are continuing to make changes to address Rental Assistance Demonstration (RAD) requirements. For those of you using PBRA, we have completed work to tie Section 8 and Conventional Housing together. This will allow the Section 8 system to update the rent information to Conventional Housing.

We have a number of enhancements planned for 2016. Make sure you are receiving our SACS News Flash emails.

Tech Tips

We have found that many of our customers are not using our batch report printing capability in Conventional Housing and Section 8. Batch printing allows you to specify the letters, leases and other documents that should be printed during move-in, reexam, and move outs.

You can configure different letters, leases and other documents based on the type of action being processed.

These actions include applicant, move in, interim reexam, annual reexam, transfers, and move out.

Batch printing insures that you print or store in Document Manager all of the forms needed for the action being processed. This eliminates the need to remember all of the different documents needed for each action.

Virus Alert!

Several of our customers have recently been attacked with crypto viruses. These viruses are commonly called ransom ware. They encrypt all of the affected user's Word, Excel and PDF documents. A message is displayed asking the user to send money to get the documents unencrypted.

We have found that this virus comes through emails. Simply opening an attachment infects the computer. At this time, there is no way to decrypt the destroyed documents. Paying the ransom is not advised. The only recourse is to restore the documents from backup.

In some cases, anti-virus software will catch and delete these viruses. In other cases, even with up-to-date anti-virus software, they still get through. We recommend that you do the following:

1. Be aware that emails can contain viruses.
2. Do not open emails with attachments from someone you do not know.
3. Never open an attachment unless you are expecting something from that person.
4. Make sure that all computers have up-to-date anti-virus software.
5. Perform routine backups of your entire computer and/or your documents.

We cannot over emphasize the need for routine backups. They are the only way to insure that your valuable documents can be restored.
