The latest SACS Software release, build 4105, has been posted on our website. The following link will take you to the updates page:

We have added new features and made several enhancements in this update. The following is a list of new features that have been added:

- A Guest Log has been added in the new release that allows users to record inquiries from the public about housing.
- Added the new payroll Form 941.
- A Workers Time program was added in the Work Orders module that allows the user to record employee times on an open work order before the work order is closed.
- A Make Deposit program has been added to Tenant Receivables. This allows users to deposit their daily tenant receivables

- to cash management. The program can also print a deposit slip.
- We now have a plug-in service that allows you to set up the system to have the SACS Calendar send a user a reminder email of a scheduled appointment.

What is the Operating Budget Form?

In the past, PHAs were required to complete the Operating Budget form - HUD 52564. This form details yearly revenues and expenses.

PHAs were also required to complete four other supporting schedules. These supporting schedules contain specific calculations that are used in the Operating Budget form.

Under Asset Management, PHAs are required to prepare budgets for each project prior to the start of each year, and have these budgets available on file. While there are no prescribed HUD-forms for the budgets, there are several formats available to reflect the conversion to Asset Management (Including those offered here at Scott Accounting).

The budget forms that may be used as

supporting schedules (For the authorities that still use them) are HUD 52566 – Schedule of all positions and salaries, HUD 52567 – Schedule of non-routine expenditures, HUD 52571 – Schedule of administrative expenses other than salaries, HUD 52573 – Summary of budget data and justifications.

Based on customer needs, we prepare operating budgets using HUD Form 52564 and the HUD supporting schedules, or using custom budget forms, including any combination of standard forms and supporting documentation.


