SACS News

On August 21, 2008 HUD published the notice of proposed rule change for the Public Housing Assessment System (PHAS). The proposed rules will require a number of changes in Sacs Housing Software. Some of the indicators have been changed along with adding new requirements.

Our staff attended a HUD class on the proposed changes. We are now waiting for HUD to release the final rule before making changes in the software. The new rules, when released, will affect agencies with fiscal year ending 6/30/2009.

Future Applications

We have received several requests for web based programs. We are current designing web modules that will allow people to apply for housing, check their position on the waiting list, and allow Section 8 owners to review tenants and payments. If you have an interest in these or other web based programs, let us know. Our developers are gathering information now.

If you are interested in issuing work orders using the PDA, let us know. We are trying to determine if there is any interest in such a program.

SACS.Net Build 3215 Released

Sacs.Net build 3215 was released on October 22, 2008. Technicians have been contacting customers to assist with installing this update. This update contains several new features and enhancements. You will find installation instructions as well as update notes on our website.

Here is a brief list of the enhancements:

SACS.Net now supports sending Landlord direct deposit notifications by email. This feature allows you to send a notification of payment by email instead of by mail. This feature can reduce your mailing cost.

SACS.Net now supports automatic Due To Due From entries in the General Ledger Module.

Has your update been installed? You can check the build number installed on your system by clicking on the menu's Help option, then About.

Technical Support

As a preventative measure, we want to remind you to perform your daily and monthly backups on a routine basis. These backups should be kept in a safe place such as a fireproof vault or better yet, an offsite location. Make sure you label your backup with the date and time that it was created. We recommend that you rotate your backup media so that your backups won't be overwritten each day.

We have had a few customers purchase Windows Vista Home edition. This version of Vista does not work well on networks. We recommend Vista Business edition for customers with a local network.

We are working on an alternative solution to Adobe for printing SACS.Net PDF forms. Several Adobe updates have caused you to receive different errors when attempting to print in SACS.Net. This alternative solution will eliminate the errors without sacrificing the print quality of the forms. We plan to have this solution ready with the next update.

SACS.Net Features

In the past few months we have made several changes to the PDA Inspection Software. One of these changes adds the ability to have a tenant sign the PDA. This signature will print on the Inspection Form.
