Build 7020 Highlights

SACS Software Build 7020 was released on 3/22/19. Listed below are some highlights from this release.

After installing this update, you can view the full release notes from the SACS Main Menu by clicking Help then Release Notes.

Accounts Payable Invoice Entry – Now interfaces with Contract Management.

Contract Management Contract Maintenance – Added a new tab to show paid invoices.

Tenant Accounts Receivable Payments and Charges – Added an option in the menu bar to update the tenant's contact information.

Tenant Data/Applications Applications – Added a menu option to roll back changes.

Setup – Added a new option "Utility Allowance Use Age" to help determine the elderly utility allowance. This assists our Georgia agencies.

General Ledger

Closing Classes – Implement user defined closing classes. Accountants can now configure the year end closing order and entries.

Maintenance System

Parameters – Added a new option to enable push notifications.

Maintenance Workers – Added fields to enable features in our Mobile Work Order app.

Section 8

Applications – Added a menu option to roll back changes.

Parameters – Added fields for the portability signer, contact, telephone, and email.

Web Applications

Online Payments – Added support for a per day penalty charge.

Developer's Corner

During the SACS User conference, we demonstrated our new products and features. Attendees saw our new SACS Dashboard, Timeclock hardware and mobile application, Vehicle Maintenance mobile application, Mobile Work Order push notifications, and the ability to roll back changes in the Applications program.

The SACS Dashboard provides a visual and graphical representation of agency information. You get real-time data of your key operating metrics. You can view this information on your desktop or mobile device.

The SACS Timeclock is integrated with our new Synergy/A terminal. See the Product Spotlight column for more information. The SACS Timeclock Mobile application allows employees to clock in/out and request leave from their mobile devices.

The Vehicle Maintenance Mobile Application allows your employees to easily record fuel purchases and service records. This eliminates the need for paper records.

We have enabled push notifications in the Mobile Work Order application. This feature requires the mobile device to have a data plan or be connected by Wi-Fi. Maintenance workers will see a pop-up message when a work order is issued to them.

Maintenance supervisors will now have the ability to reassign work orders from the mobile device. When a work order is reassigned and synced with SACS, the assigned employee will receive a notification.

The Applications programs now have the ability to roll back changes. Users can select a prior rent change and have the information for that certification replace the current information in Applications. This will allow users to easily revert back to previously made changes.

Tech Tips

Waiting List Position Inquiry

The Waiting List Position Inquiry program is available in both Section 8 and Conventional Housing. This program allows you to quickly view an applicant's position on the waiting list.

Your waiting list selection and sort preferences will need to be established using the Data/Applications Setup program. On the Specifics 1 tab, select the application status and sort order to include. These selections tailor the Waiting List Position Inquiry to fit your agency's needs.

Backups

It is important to keep good backups of your housing data, letters, and emails. In the event of a disaster your data can be quickly restored. The proliferation of viruses and ransomware makes this a top priority.

We recommend that you keep five independent backups, one for each day of the week. If you are using an external hard drive or jump drive, do not leave it connected to the computer. It should be disconnected after each backup and stored in a secure location. Viruses will destroy information on any connected drive.

Know what you are backing up. We always recommend backing up your housing databases, special formats and letters. In addition, you should backup your personal letters and email correspondence. Some of this information may or may not be stored on your server.

We have an optional Remote Backup Service (RBS) that backs up housing data automatically every weekday night.
