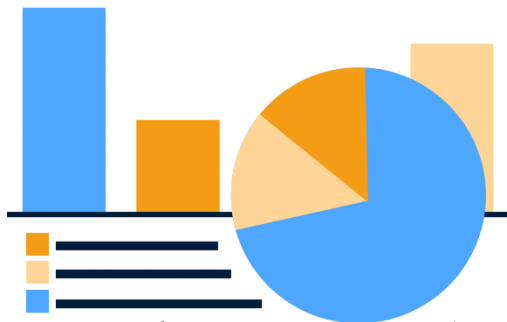

## Build 7122 Highlights

SACS Software Build 7122 was released on 7/3/2019. Listed below are some highlights from this release. After installing this update, you can view the full release notes from the SACS Main Menu by clicking Help then Release Notes.

### Conventional Housing

Applications – Added support for new SACS Investigator requirements.

Batch Reports – Added an option to select desired reports.

Move In Applicant – Added a message to prompt user to confirm move in.

Transfer Tenant – Added a message to prompt user to confirm transfer.

### Contract Management

Bid Maintenance – Added an inventory search button on the Bid Detail Item screen.

### Maintenance System

Work Order Entry – Added support for push notifications when adding a work order or when an assigned employee changes.

Work Order Entry – Now allows users to reassign work order to the originally assigned worker.

### Previous Tenants

Previous Tenants/Applicants – Now allows user to select and attach multiple files.

### Section 8

Owners – Changed to show payments received on History tab. Displayed as type “P.”

Status Code Report – Added new report to print applications for a selected status code.

### Web Applications

Web Application – Changed the online application to allow restrictions on head of household’s age.

## Developer’s Corner

As we move into the hot days of the summer, your developers have been busy with changes. Build 7122 has over 150 changes and improvements.

Our web application suite now has a new look and feel. This upgrade takes advantage of the latest web technology. In order to receive this update, you will need to contact SACS Technical Support.

The online web application now has the ability to restrict applications to a defined set of options. The minimum age of the head of household can now be specified. You can also specify a minimum and maximum number of members by waiting list. This option works well with bedroom size based waiting lists.

The tablet Vehicle Maintenance app has passed initial testing. The Work Order app has

passed beta testing. Both will be released for general use by the end of July.

HUD has postponed TRACS 203A until later this year. We will continue to implement changes for the new fields needed for these changes.

We have updated all of our Tax Credit forms. These changes are based on feedback from you. We recommend you update your system with these changes.

All of our company and hosted websites now use secure sockets. All communications to our web servers are now encrypted with a secure certificate. While SACS never stores any personal data, we do recommend that all websites be secured.

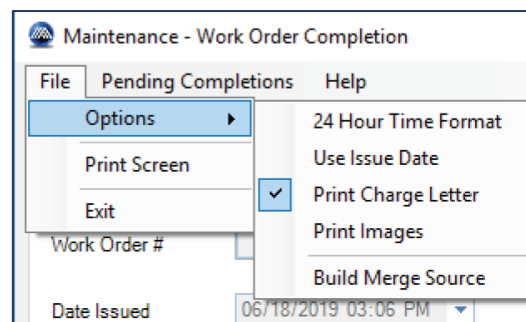

## Tech Tips

Tenant Charge Letters can be automatically printed when using the Complete Work Order Program. This option is enabled by using the File option. Click File, from the dropdown select Options then Print Charge Letter. The option should be checked for automatic printing.

With this option enabled, Charge Letters will print automatically

with the completion of every work order.
